### Definitions

A certificate is 'a statement in writing by a person having a public or official status concerning some matter within his knowledge or authority'.

### Definitions

'Certificate means a document issued by an Administration or its representatives that is used to show compliance with IMO requirements and used to describe operating conditions, crewing requirements, and ship equipment carriage requirements. The term 'certificate' does not include publications, manuals, instructions or ships' logs used to record ongoing operations'.

### Definitions

'Electronic certificate means a certificate issued in an electronic format'.

# Is it legally valid?

'Administrations that use electronic certificates should ensure that these certificates have the following features: ... validity and consistency with the format and content required by the relevant international convention or instrument, as applicable. ...'

# Is it legally valid? (tbc)

'All stakeholders should accept electronic certificates containing the features identified in section 4. These electronic certificates should be verified, when necessary, following the instructions available on board the ship (see paragraph 3.4). Furthermore, port State control officers, in accepting electronic certificates, should follow the Procedures for Port State Control, 2011 (resolution A.1052(27)).' (Emphasis added.)

In this regard, please note that, the Maltese Registry is now accepting electronic documents and certificates that comply with the recently adopted "Guidelines for the use of electronic certificates" (FAL.5/Circ.39/Rev.2) by IMO, as an equivalent to the usual practise of paper documents.

It is to be noted that statutory certificates issued by Recognised Organisations on behalf of the Malta flag Administration may either be presented in an electronic format in accordance to the FAL.5/Circ.39 or still be presented in an original paper format.

The Maltese Administration encourages the use of electronic certificates as part of the initiative to reduce the administrative burden in the industry and advocates the maritime industry's transformation towards smarter ships and intelligent ports.

The Government of Malta avails itself of this opportunity to renew to the Secretary General of the International Maritime Organisation the assurances of its highest consideration and esteem and requests him to bring the contents of this letter to the attention of all Member States.
