



Social and Market Concerns: «Soft Law» Tools

Contract tools:

Ex: Climate contract clauses.

Corporate tools:

- > Voluntary Sustainability Standards (VSS)
- Social enterprises, esp. for community transport services.

The Lawmakers' Role

Contract content

- 1. E.g.: the Italian regime of road freight transport (Law No 286/2005).
- 2. Clauses and VSS in public procurements?

Corporate aspects

1. The company's structure, such as **social enterprises**.



Conclusions. Hints for Discussion

- Fragmentation of political and legal approach towards the several shades of sustainability in the different transport modes and in logistics.
- Some aspects are still not considered by policy and law makers at the international level.
- It is difficult to assess how and to what extent are «Soft law» tools contributing.
- Importance of the intervention by the policy and law makers on critical issues, but limits to it.
