Sir Geoffrey Nice has practised as a barrister since 1971. He worked at the International Criminal Tribunal for the Former Yugoslavia - the ICTY - between 1998 and 2006 and led the prosecution of Slobodan Milošević, former President of Serbia. Work since has included cases before the permanent International Criminal Court - Sudan, Kenya, Libya - or pro bono for victims groups - Iran, Burma, North Korea - whose cases cannot get to any international court. He works for several related NGO's and lectures and commentates in the media in various countries on international war crimes issues. He was a part-time judge from 1984 to 2018, sitting at the Old Bailey. He also sat as judge in other jurisdictions, tribunals and inquiries. Between 2009 and 2012 he was Vice-Chair of the Bar Standards Board, the body that regulates barristers. He was Gresham Professor of Law from 2012 to 2016. He is the co-founder and Executive Director/Chair of the Geoffrey Nice Foundation on Law, History, Politics, and Society in the Context of Mass Atrocities, which supports and provides cross-national educational opportunities for students, researchers, and academics in the field of International Criminal Justice. His publications include the book "Justice for All and How to Achieve It," (London, 2018). Sir Geoffrey has been Chair of two tribunals that investigated large-scale atrocities and human rights abuses in China: the China Tribunal (2018-2-2019); and the Uyghur Tribunal (2020-2021).

Sonja Biserko is the founder and president of the Helsinki Committee for Human Rights in Serbia. She has written extensively on the wars in the former Yugoslavia and war crimes including the Srebrenica genocide, the fall of Vukovar, and on the trials of Slobodan Milošević and Vojislav Šešelj. She was a founding member of a European movement in Yugoslavia and the Centre for Anti-War Action in the Belgrade Forum for International Relations as well as a senior fellow in the United States Institute of Peace. In 1994 she received the Human Rights Award of the Lawyers Committee for Human Rights in New York. In 2005 she was a part of the group 1,000 Women for Peace nominated for the Nobel Peace Prize. She was awarded the 2009 Human Rights Prize of the City of Weimar jointly with Jestina Mukoko and the Human Rights Award of the University of Oslo in 2010.

Associate Prof. Dr.Dr.h.c.Sunčana Roksandić obtained her PhD in 2015 (Zagreb) and 2016 (Freiburg) as a doctorate scholarship holder and doctoral candidate of the Criminology Department at Max Planck Institute of Foreign and International Criminal Law (summa cum laude). Her book, based on her doctoral research under the title Prosecuting serious economic crimes as international crimes, a new mandate for the ICC? was published in 2017 by Duncker & Humblot.

She received an honorary doctorate (doctor honoris causa) in 2019 at East European University, Tbilisi, Georgia for her work and activity related to "the responsibility of transnational corporations and other business enterprises for breaches of human rights." She is a scholarship holder of the Foundation Marija i Mirjan Damaška for her postdoctoral research (2019/2020).

Born in Zagreb where she finished elementary school and attended Gymnasium (Gymnasium for classical languages). She graduated in the USA. She obtained her Master of Science Degree in Company and Commercial Law at the Faculty of Law, University of Zagreb (2011) and graduated at the same Faculty of Law (2000), all in top 3%. After graduation, she worked seven years in legal practice, first as he legal trainee in the law firm Bogdanovic, Dolicki & Partneri later as legal adviser to Croatian Medical Chamber. For her work in the Croatian Medical Chamber she has received a special recognition - an award for the contribution to the development of the Croatian Medical Chamber (2005). She passed the Croatian bar exam. Since 2021, she serves as an external member of the Legislative Committee of the Croatian Parliament. In January 2023, she was appointed a member of the Council for the Implementation of the Code of Conduct of the Highest State Officials. She is also a member of the Council of GONG. Sunčana teaches criminal law, economic criminal law, transitional justice, EU substantive criminal law and the protection of victims (Jean Monnet Module co-Leader) and bioethics and human rights (UNESCO Model Course) at Faculty of Law, University of Zagreb. She also teaches medical ethics at the Medical School, University of Zagreb.
