



- - **Ownby (1999):** 1. "Dream of Abundance"
 2. "Dream of a Democracy of Goods"
 3. "Dream of Freedom of Choice"
 4. "Dream of Novelty"
 - **F. Scott Fitzgerald:** Modern society is taking over and replacing the American Dream with corruption and bare materialism
 - **Wuthnow** (1996): Youth have become collateral damage of neoliberal politics and active agents of materialism
 - **Giroux (2009):** Young people have become a generation of suspects in a society destroyed by the merging of market fundamentalism, consumerism, and militarism, behaving in a way that was unthinkable 20 years ago, including criminalization and imprisonment, the prescription of psychotropic drugs [and] psychiatric confinement.




New American Dream → "the Dream of the Coast"

- → personal fulfilment of fame and fortune all the more attractive if achieved without obvious effort (Cullen, 2004)
- Culture is characterized by a strong emphasis on the goal of monetary success and a weak emphasis on the importance of the legitimate means for the pursuit of success
- The American Dream contributes to crime directly by encouraging people to employ illegal means to achieve goals that are culturally approved (Messner and Rosenfeld, in Inderbitzin, 2007:236).





EUROPEAN DREAM (Jeremy Rifkin)

- → a step for a development of more caring and better connected society
- → a dream of hope: inclusion, diversity, quality of life, sustainability, commitment to self, human rights

"The relationships within the community are more important than individual autonomy, cultural diversity is more important than assimilation, quality of life more than the accumulation of wealth, sustainable development more than limited material growth"

- → will overcome the raw power and establish a moral conscience which will lead the humanity
- → will give young people the power on the "journey towards a third stage of human consciousness

SOCIAL WORK IN CROATIA 2011

- Development strategy for social welfare system 2011
 2016.
- **PRIMARY OBJECTIVE** → improve the position of the most endangered population, elimination of poverty and social exclusion
- Modernization of systems and further compliance with the criteria and standards applicable in the European Union



PRIORITIES

- 1. Increase the effectiveness of social assistance
- 2. Implement the decentralization of social welfare
- 3. Increase the availability and quality of social services to the regional uniformity
- 4. Stop the trend of institutionalization and deinstitutionalization of conduct and the transformation of welfare homes and other legal entities
- 5. Implement computerization of the social welfare system
- 6. Improve foster care in the Republic of Croatia
- 7. Enhance cooperation with civil society organizations
- 8. Provide conditions for the continuous training of employees
- 9. Strengthen the role of local communities in the planning of services at local level
- 10. To create conditions for monitoring and evaluating the provision of social services
- 11. Improve the integration of social services
- 12. Increase the efficiency of pre-accession EU funds, the program of the European Union and the Structural Funds
- 13. Encourage cooperation at national, regional (county) and local (city and municipal) level in the provision of services
- 14. Improve interdepartmental cooperation



MEASURES

- 1. Improving the social welfare system by applying the new law on social welfare with Human Resource Development
- 2. Promoting professional chambers
- 3. Changing Ministry of Health and Social Care
- 4. Decentralization of social welfare
- 5. Redefining financial assistance and improving the situation of vulnerable groups
- 6. Expanding the network of social services
- 7. Intergenerational solidarity
- 8. Foster Care
- 9. Improving cooperation with civil society organizations (NGO's)
- 10. Changing social care in municipalities
- 11. Changing other legal entities of social welfare
- 12. Computerisation of the social welfare system
- 13. Informing and educating citizens
- 14. Monitoring and eevaluation
- 15. Preparation and implementation of activities in the field of social inclusion
